ELECTIONS IN 47 ASSEMBLY SEATS IN 13 STATES

Bypolls: Nomination process ends

Lucknow/Jaipur, October 25

WITH THE FILING of nominations for bypolls to 47 seats spread across 13 states ending Friday, a big test awaits the opposition INDIA bloc in this crucial showdown with the BJP as the Congress also faces alliance challenges.

Voting will be held on November 13 in nine seats of Uttar Pradesh, seven seats in Rajasthan, six seats in West Bengal, five seats in Assam, four seats each in Bihar and Punjab, three seats in Karnataka, two seats each in Kerala, Madhya Pradesh and Sikkim, and one seat each in Chhattisgarh, Gujarat and Meghalaya.

Bypoll will also be conducted in the Wayanad Lok Sabha seat that day. Most of the seats fell

vacant after the sitting MLAs were elected to the Lok Sabha as MPs while in some constituencies, the bypolls are being held due to death of the representative.

The INDIA bloc, which failed to put up a united fight in the recently-held Haryana assembly polls resulting in the

in Uttar Pradesh, bypolls are being held in Katheri, Kathal, Meerapur, Kundark, Phulpur, Sisaman, Ghaziabad, Majhawan and Kahir.

Eight of these seats fell vacant after the MLAs fought the Lok Sabha elections and won, while bypoll in Sisaman is being held due to the disqualification of SP MLA Irfan Solanki, who was convicted in a criminal case.

The BJP left the Meerapur seat in Muzaffarnagar for its ally IJD. The BJP put up candidates in all the remaining eight seats, an Nephari slight to its other ally Nishad Party that had earlier staked claim to two seats—Majhawan in Mirzapur and Katheri in Ambikapur.

BJP winning comfortably, could not agree on a seat-sharing arrangement in Uttar Pradesh for the bypolls. The Samajwadi Party is finally contesting on all the nine seats with the Congress deciding to opt out though it announced it will hold "joint campaigns" with its ally.

Baba Siddique killing: 15 arrested so far

MUMBAI POLICE ON Friday arrested a person in the murder case of NCP leader Baba Siddique from Ludhiana in Punjab. Sujit Sushil Singh (32), a resident of Ghatkopar in Mumbai and the 15th person to be held in the high-profile case, was linked to abducting accused Zeeshan Akhtar, one of the alleged masterminds of the killing, a crime branch official said.

Elsewhere, the investigators seized a pistol from the rented house of one of the arrested accused in Panvel area near Mumbai.

In the hierarchy of the conspirators, Sujit was above Nitin Sapre and Ram Kanoujia (both arrested), the official said, adding that Sujit and Akhtar took instructions from above and passed them to the Sapre and Kanoujia.

Sujit, resident of Chhedra Nagar in Ghatkopar, fled Mumbai a month before the crime which took place on October 12, and was staying with his relatives in Ludhiana, the official said.

Crime branch officials also traced his financial transactions with Kanoujia and Sapre, the official said. The money was given to the alleged shooters and others involved in the crime, he added.

The masterminds used dif-

ferent people to provide money to the members of different "modules" of shooters hired for the killing of the NCP leader, the official said.

Baba Siddique (66) was shot by three gunmen near his MLA son Zeeshan Siddique's office in Mumbai's Bandra area on October 12.

Meanwhile, a pistol and three bullets were recovered from Ram Kanoujia's rented house in Palisape area of Panvel town in neighbouring Raigad district, the crime branch official said.

Kanoujia (43), arrested last week, was part of the group that allegedly provided firearms and logistical support to the shooters.

So far, 14 persons including alleged shooters have been arrested in the high-profile murder case.

While police sought the extension of remand by three days, the court extended it by one day.

The nine accused produced before the court were Gurnail Bajjit Singh (23), Dharmraj Kashyap (21), Harish Kumar Nisad (26), Pravin Lonkar (30), Nitin Gautam Sapre (32), Sambhaji Kisan Pardihi (44), Pradep Dattu Thombre (37), Chetan Dilip Pardihi and Ram Fulchand Kanoujia (43).

Modi likely to address 12 election rallies in Maharashtra

Nagpur, October 25

PRIME MINISTER NARENDRA Modi is likely to address 11 to 12 public meetings in Maharashtra ahead of the next month's assembly elections, BJP's state unit chief Chandrashekhar Bawankule said on Friday.

Elections to the 288-member state assembly will be held on November 20 and the counting of votes will take place three days later.

Addressing a press conference in the Bharatiya Janata Party's media office here, where former MLA Raju Todsan (from Arni in Ravatmal) and few other local leaders joined the party, Bawankule said, "PM Modi's public meetings are proposed to be held at 11 to 12 places across Maharashtra, including Gondia, Akola, Nanded, Dhule, Mumbai and Navi Mumbai." He added that in the next few days, more people are expected to join the Mahayuti alliance.

The ruling Mahayuti alliance comprises the BJP, Eknath Shinde-led Shiv Sena and Ajit Pawar-led Nationalist Congress Party (NCP).
